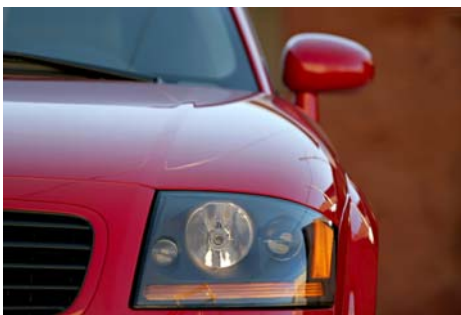


# Contract Purchase

Contract Purchase is an efficient form of funding for the more expensive fleet cars or for organisations which cannot fully reclaim VAT.

A Contract Purchase agreement from Bramall & Jones Leasing offers all the benefits of a Contract Hire agreement yet enables you to have full ownership to the vehicle with associated balance sheet implications.



For a fixed monthly payment you can let Bramall & Jones Leasing fund and manage your vehicles while retaining the option to fully own the vehicles should you wish.

From a financial perspective it might make sense to utilise Contract Purchase for vehicles with a capital cost in excess of £25,000. If as an organisation you are restricted from reclaiming all your VAT then Contract Purchase offers you the benefit of no VAT being levied on the finance element of the rental.

The decision to use Contract Purchase as a form of funding can be complex but it is worth considering as part of your portfolio of options for your fleet.
